	specific financial account numbers (such as a creditcard number or an account number for a home					
	mortgage or auto loan). The transcript displays online upon successful completion of the IRS's two-step authentication.					
•	Automated Telephone Request-1-800-908-9946. Transcript is generally received within 10 business days					
	from the IRS's receipt of the telephone request.					
•	<u>Paper Request Form</u> — IRS Form 4506T-EZ or IRS Form 4506-T. The transcript is generally received within 10 business days from the IRS's receipt of the paper requestform.
